

#### TERMS AND CONDITIONS OF ACCESS

IMPORTANT – READ CAREFULLY: These Terms and Conditions of Access (these "Terms") are a legal contract between you (a "User") and Advanced Wireless, Inc. ("AWI"), for the use of this Internet Website (this "Website"). Access to and use of this Website by any User is subject to these Terms, including any modifications or additions to these Terms from time to time issued by AWI and all applicable laws and regulations. Accessing or using this Website indicates that User has reviewed these Terms, agrees to be bound by these Terms, and represents and warrants to AWI that User is authorized to enter into and be bound by these Terms on User's behalf or on behalf of the entity that User represents.

### 1. General

- a) AWI maintains this Website to provide information about AWI and its products, and to facilitate the purchase of AWI products on this Website by registered Users. # 2. Changes in Terms; Termination

- a) AWI shall have the right at any time, and from time to time, without prior notice, to modify these Terms or to impose new terms and conditions with respect to access to or use of this Website. Notice may be given by any means, including, without limitation, posting the modified or additional terms and conditions on this Website.
